# Master's exams Chemistry

## For the following modules you need to take an oral exam:

Chemistry: CM1-IC, CM2-OC, CM3-PC (3x Mandatory module), Mandatory elective module, Elective module (if applicable)

### Registration deadline and examination period:

The registration deadline is November 27th 2020, the exams will take place middle of Februar till end of March.

In case you have restrictions in the examination period, please note them **on** the registration form.

#### Suggestion of examiners and dates:

For the mandatory modules, please indicate when you attended the classes (WS and SS) and which lecturers you had.

For the exams in the Mandatory elective and the Elective module, please indicate which module (name!!) Here you can suggest two examiners (please name three if possible). However, there is no guarantee that your selection will be fulfilled. In principle, all instructors who are listed in the module handbook are potential examiners for the respective modules, if necessary further examiners can be added to the list.

After submitting the form to the "Student-Service-Center" according the deadline, the Examination Office (Prüfungsamt) will be informed three weeks before the finalized dates. At this stage, you will be informed about the time, place and members of the evaluation committee; this information will also be available online via "MeinCampus".

#### Further comments

Exams for "external" classes that are not taught within the Department of Chemistry and Pharmacy (DCP) will not be organized by the "Student-Service-Center". You will be in charge of organizing such exams. Please inform us when you have organized an "external" exam to avoid a conflict with exams in DCP.

#### Corona

Due to the special situation we are facing due to the Corona-Virus, we might have some restrictions for the exams. You will be informed.

#### Exam

You need to bring the respective docket of the module for the exam. Classes, which have been attended during the SS 20 via zoom or any other digital media, have to be marked accordingly. A signature of the lecturer is not required. For required practical work, presentations, ... the signature of the lecturer is needed, a printed confirmation will be accepted.
